## From washing dishes to cleaning up finances

The \$2 an hour pay was thrilling and awe-inspiring.

And in the back of the restaurant, a shy Grant didn't have to chat up customers or check endlessly on the satisfaction of their meals.

Now, Grant seeks out that connection and conversation, thanks to another job that helped him relinquish his shyness and help a friend save money — foreshadowing his life's work.

When that friend couldn't afford a DJ for his wedding, Grant stepped in.

"Give me a microphone and I become a totally different person," Grant said. "It brought me out of my shell and gave me the confidence to talk to people. Music is the international language of the world, and it is great to see how happy people become when you play their song."

Grant uses his voice in his role as director of financial planning at AXA Advisors' South Florida branch.

New to Grant's list of greatest hits: He recently won AXA's 2010 National Honor Associate Award. He was chosen from thousands of employees for the annual award established nearly 70 years ago.

He told us how he went from washing dishes to helping people clean up their finances.

Q. Is the job you have now one you pictured yourself doing when you were 5? 15? 25? Or what was the inspiration for your current work?

**A.** I was actually inspired by a client to become a financial advisor. In my prior job as a branch manager for a bank, I regularly scheduled informational seminars for my clients, arranging with accountants, attorneys

Q. What is the worst thing employees or co-workers say about you behind your back?

**A.** Over the past 25 years I have prided myself on customer service; I return most calls — when I am not in a meeting — within two hours.

**A.** At first I resisted changing from my regular telephone as my method of communication. But the BlackBerry has increased my effectiveness in communicating with my clients, which is one of the foundations of good customer service.

Q. What's the best bit of career advice you ever heard?

**A.** If you are not happy in your current career, try going back to school to learn to do something vou really love. If you have passion about what you do — as I do as a financial planner — then it is not work and you will do it with pleasure.
